Attendance

All PP children will have their attendance monitored monthly.

Parental Engagement

PP provision is discussed with parents and parents guided on how best to support their child at home. Discussions take place with parents, asking about strengths and difficulties. Barriers to learning analysis completed by the class teacher and discussed with staff and parents.

Transition meetings between years.

We find out how they prefer to learn and plan accordingly.

We find about their hobbies and interests and ask them about them.

We find information about their context and background.

Detailed tracking sheets are taken from Target Tracker so staff are aware of children's starting points and can accurately measure progress.
